    - **263** Calls were the result of Richmond, VCU, and VUU police officers conducting Lethality Assessment Protocol (LAP) when responding to intimate partner violence.

The Sprout School, our high-quality, mixed income early education and infant care model served 121 students between the ages of 2 months and 5 years between both our Bainbridge and Children's Museum locations.

After leaving Fan Free Clinic, she went on to Richmond City Health District.

The 1st Transgender Women of Color to work for the cities health district, she served for 6 years as a Disease Intervention Specialist. Helping to locate and diagnose and treat individuals who were exposed or at risk of contracting sexually transmitted infections. After leaving Richmond City, Zakia founded and directs Nationz Foundation. Nationz Foundation is a nonprofit 501c3 organization founded in October of 2015. Nationz provides free HIV testing as well as linkage to care services and a food pantry to assist those clients in need or who are experiencing hardships in life. Nationz Foundation provides emergency housing assistance as well as transportation to and from medical appointments and support services. Nationz Foundation has 2 mobile testing units to provide services in the community to those who don't have access to their office or services.

Zakia has been Named "Outstanding Virginian 2018" by Equality Virginia and she has been honored with The 2018 "Firework Award" from Virginia Pride, the 2018 1st Annual"Global Award" winner from the Heart of the Community Awards and the 2019 Zodiacx Iman Award. She believes in an "Aim to Inspire" attitude. Hoping community members will aspire to be their best selves and take responsibility for their health and wellness and unite and stand in solidarity as a community.

Jumpers Foundation, named after her son JP, to positively impact the special needs community. Through the JP JumPers Foundation, she has raised money, awareness, and education for these oftentimes overlooked individuals.

In 2014, Pam initiated legislation to establish "JP's Law" (SB367) in Virginia. This law allows individuals having Autism or an Intellectual Disability to voluntarily add an innocuous code to their driver's license / identification card noting they have a diagnosis, aiding law enforcement and first responders in their interaction with them. In April 2019, our nation's capital, the District of Columbia adopted "JP's Law". To date more than 2,000 people have this specialized ID.

Pam's work, advocacy, and ability to inspire meaningful change has been recognized via several awards since 2009. Now, she is proud to add to the list, the 2022 YWCA Outstanding Woman under the category of Volunteerism.

Pam continues to speak, train, give, and advocate. She feels blessed and grateful that God saw fit to trust her with such a tremendous responsibility. She doesn't see herself as the voice for the special needs community, simply A voice for those with special needs. This remarkable woman hopes to positively impact the masses and show them that through giving and compassion they can also be Change That Moves!!

In its 7th year, YWCA Richmond continues to award the Pat Asch Fellowship for Social Justice, in honor of Pat Asch, former

Executive Director of YWCA Richmond and the Jackson Foundation. The Pat Asch Fellowship for Social Justice invests in a local woman in the Greater Richmond region, who is at least 50 years of age, to focus on a deeply personalized, year-long leadership and professional development journey.

Are you a woman 50 years or better with a vision for yourself and your community? YWCA Richmond recognizes one woman annually who has the passion to bring about change in her own life while championing for social justice in her community. The fellowship is a \$17,500 investment in her leadership and development journey. Experiences that are supported include: training, coaching, education, subsidies to encourage re-entering the workforce, research, innovation or work within a new constituency.
