## **Nomination Categories**

<b>Arts &amp; Culture</b> : She may be a creator, performer, advocate, manager, owner, or volunteer leader who is committed to promoting the vital and unique role of arts in the community.
This woman has helped shape our cultural community through her involvement in the visual, performing or literary arts.
<b>Business</b> : She is a business leader and innovator in a for-profit organization and is guided by
a strong set of personal values. She inspires and empowers employees and coworkers and
uses her business acumen to bring positive change and impact to the community. This
woman excels in her business or profession, is highly respected by her peers, and is a role
model for other women in her field.
<b>Education</b> : She is innovative, resourceful, and dedicated to the critical role educators play in
our society. Through her work in a traditional or non-traditional setting, she strives to have a
lasting impact on those she encounters in an educational environment. This woman is
dedicated to helping others achieve educational success.
<b>Health &amp; Science</b> : She is a science or health professional who has achieved distinction in her
field for her scientific, medical, or humanitarian advancements. This woman's
accomplishments are recognized as important contributions to the wellbeing of humanity.
Human Relations &/or Faith in Action: She demonstrates an ability to build bridges
between diverse groups, to work for the betterment of others, and/or to enhance the
quality of life of members of our community. This woman's actions are guided by her
engagement with others and her passion to inspire, lead, and support those with whom she
shares her commitments and values.
Law &/or Government: She is recognized by her colleagues and those she serves as a
proponent of social justice, an advocate for fairness and equality, or a builder of bridges between the private and public sectors. This woman may be a law professional, elected
official, lobbyist, advocate, or government employee who contributes to the betterment of
legal and/or government entities.
Media & Marketing: She effectively uses media platforms to advocate, inform, educate, and
expand or impart knowledge and information to make the world and community in which
we live a better place. This woman excels in the field of communications, whether it is
media, public relations, advertising, marketing, information technology, or a related
profession.
Nonprofit Leadership: She is devoted to building, promoting and sustaining excellence in
the nonprofit world. She is a steward of best practices with the ability to build and grow this
sector. This woman is a leader in the community and serves as an administrator, staff
person, or volunteer with a nonprofit organization.
<b>Volunteerism</b> : She gives back to the community, acts on the power of her convictions, and
inspires others by her example. This woman contributes to the community by voluntarily
offering her time and expertise to people, organizations, or causes in which she believes and
for which she can affect positive change.
